Introduction to the Progran:

The recent wave of returnees and the growing IDP population have put an enormous pressure on Afghanistan's inundated service delivery systems, as well as on the social, economic and physical infrastructure of the communities that host these groups. The Eshiteghal Zaiee – Karmondena (EZ-Kar) is a Project that proposes to mitigate the enormous pressure caused by the displacement crises, while also enhancing the opportunities it presents for economic development. Thus EZ-Kar fits within the international context of integrating humanitarian approaches with development. There is a strong emphasis in the project on regulatory reforms at

municipal and national levels to support business owners and enhance the ease of doing business, developing market-based infrastructure, and creating short and medium term economic opportunities as well as removing impediments to their re-integration. The Project Development Objective (PDO) is to provide an enabling environment for economic opportunities in cities where there's a high influx of displaced people. The EZ-Kar project will reach Afghan refugees living in Pakistan and citizens within Afghanistan in 13 cities in Afghanistan namely: Jalalabad (Nangarhar), Kabul City (Kabul Province), Kandahar City (Kandahar Province), Herat City (Herat Province), Puli Khumri (Baghlan), Maimana (Faryab), Ferozkoh/ Chaghcheran (Ghor), Khost Matun (Khost province), Asadabad (Kunar), Kunduz City (Kunduz Province), Mehtarlam (Laghman), Parun (Nuristan) and Taloqan (Takhar). The EZ-Kar is again an inter-ministerial approach to the displacement crises, with multiple implementing agencies (IAs) including the Ministry of Foreign Affairs (MoFA), the Ministry of Economy (MoEc), the Kabul Municipality (KM), and the Independent Directorate of Local Governance (ILDG).

The MoEC handles Component #5 of the EZ-Kar which includes: (a) national level regulatory reforms and (b) serving as the lead agency for the Program and thus coordinating between the four different implementing agencies for all five components. The MoEC will execute this through a Project Implementation Unit (PIU) embedded within the Ministry's Directorate of Local Services, under the Deputy Ministry for Technical Affairs.

Part of the MoEc's responsibilities under Component #5 includes reviewing all investments/ priority projects/ subprojects proposed by the Independent Directorate of Local Governance (IDLG) for Components 2.2 and 3, and by the Kabul Municipality (KM) for Component 4. The proposals need to be reviewed against the Public Investment Management (PIM) framework criteria. Given the greater experience of the MoF in this regard, the MoF will be seconding the staff in these positions to the MoEc EZ-Kar PIU to support the Ministry for this responsibility

Prepare clear criteria for the review of all investments stated above using a SIMPLIFIED PIM framework. Prepare and disseminate clear Project Concept Note (PCN) templates that respond to the criteria.

Provide trainings to the IDLG and KM EZ-Kar teams to ensure that the responsible teams for preparing the concept notes for the Component 2.2, 3 and 4 are fully informed of the template and basis for approval.

Maintain soft and hard copy lists of all project concept notes (PCNs) received from

The IDLG from Business Gozars for subprojects under Component 2.2,

The IDLG from Municipalities of the cities of Kandahar, Herat, Jalalabad and Khost for priority projects under Component 3,

The KM for priority projects in Kabul city under Component 4.

Record PCNs into IBP and maintain hard and soft documentation of PCNs received from line ministries/private sector etc.

Receive and carry out initial screening of PCNs.

Provide recommendation on strategic fit analysis to PEC and file PEC decisions into IBP.

Provide recommendation on Pre-Feasibility Studies at the second stage and file PEC decision/minutes into IBP.

Provide recommendation on Feasibility Studies at the third stage and file PEC decision/minutes. Coordinate PCNs and other responsibilities/tasks with PIM Directorate, MoEC, President's office (if the position is placed in CPA).

Enter summarized details of all PCNs that are approved into the MoEc EZ-Kar database.

Performance-Based Grant Disbursement Approvals

Review the requests from IDLG and KM for second and third tranche disbursements for the approved subprojects/ investments.

Ensure that the construction permit reform action plan has been prepared, for Components 2.2, 3 and 4, and the City Investment Project (CIP) reform requirements for Component 3 have been met satisfactorily before approving disbursement of tranche #2 of the grants.

Ensure that the construction permit regulatory reforms have been implemented before approving the disbursement of tranche #3 of the grants for Components 2.2, 3 and 4.
