1. Background:

In November 2016, the GoIRA formed the 'Displacement and Returnee Executive Committee' (DiREC) to provide policy and operational support for the development of a policy framework and coordination of humanitarian and development efforts. The concept of the EZ-Kar project derived from the interlinked DiREC strategy and corresponding multi-ministerial technical working groups - which agreed on a programmatic approach. The project was formally signed and agreed upon between the World Bank and the Government of the Islamic Republic of Afghanistan (GoIRA) in December 2018. The project's development objective is to strengthen the enabling environment for economic opportunities in cities where there is a high influx of displaced people. This will be pursued by increasing the returnees' access to civil documents, providing short-term employment opportunities, improving market enabling infrastructure, and supporting investor-friendly regulatory reforms. The Project targets Afghan refugees living in Pakistan and in 13 provincial capital cities with the highest influx of the recent returnees. The cities include: Kabul, Jalalabad, Kandahar, Herat, PuliKhumri, Maimana, Ferozkoh, Khost, Asadabad, Kunduz, Mehtarlam, Taloqan and Parun. The project has five components that would be implemented by Implementing Agencies (IAs) as shown below:

- a) Component 1: Regional and National integration of displaced persons by the Ministry of Foreign Affairs (MoFA), primarily issuing passports to Afghan refugees in Pakistan)
- b) Component 2: Short term employment opportunities, reforms, market enabling infrastructure, and municipal level regulatory reforms in 12 cities by the Independent Directorate of Local Governance (IDLG),
- c) Component 3: Priority Investments in 4 Provincial Capital Cities by the IDLG,
- d) Component 4: Market enabling infrastructure and regulatory reforms for Kabul city by the Kabul Municipality (KM), and
- e) Component 5: Project coordination, red carpet and national level regulatory reform by the Ministry of Economy (MoEC)

2. Project Objectives:

The project's development objective is to strengthen the enabling environment for economic opportunities in cities where there is a high influx of displaced people

3. Scope of Work:

a) General: The consultant will be reviewing and assessing the gaps in the existing national level legal and regulatory framework related to construction permits for commercial properties (i.e. high-rise, warehouse, small commercial buildings, industrial buildings) from technical/municipal expertise perspective and develop a national level regulatory reform plan for construction permits.

b) Specific:

- Work closely with the Legal Consultant in undertaking gap analysis and developing a detailed action plan for reforms in construction permitting at the national level
- Provide technical assitance to the Legal Consultant in assessing legal framework governing construction permitting and reviewing the related legal documents, policies, etc. given national and international standards
- Review various forms, applications and plans related to construction permit.
- Consolidate and anlayze existing gaps in the building codes and other technical documents related to construciton permits and provide recommendations
- Assess the construction inspections by municipalities, police, etc. from technical perspective and propose simplified path and provide technical recommendation on removing the redundant and unnecessary steps.
- Provide technical/engineering assistance to the Legal Consultant and MoEc PIU in conducting construction permit process mapping at the national and municipal levels to depict actual practice vs. legal requirements and identify redundant, non value adding as well as adhoc steps that have no legal basis through conducting desk review, research and holding meetings and interviews with relevant government and private sector entities.
- Collaboratively assist with the Legal consultant and MoEc PIU in finding the practical challenges to current existing construction permitting process and make recommendations.
- Provide technical expertise/advice on construction permitting process i.e. land title, approval of construction designing, drawings, zoning and sketching, inspection, quality control, safety, etc. at each stage of the project from gap analysis to developing action plan
- Develop data collection and data analysis tools in close consultation with the Legal Consultant and MoEc PIU for EK-Kar Project
- Undertake field visits for the purpose of collecting relevant data as well as data entry and data analysis
- Work jointly with the Legal Consultant to draft and finalize Gap Analysis (Assessment) report and action plan in close conjunction with MoEc PIU and relevant stakeholders
- Coordinate closely with KM, IDLG, CCAP and KMDP and use their inputs (Kabul, Kandahar, Herat and Jalalabad CP gap anlysis) while doing CP gap analysis and preparing the action plan to avoid overlap, and ensure cooridation and consistency of data.
- Provide regular reporting to the management on the progress of activities

5. Qualification and Experience Requirements:

- a) Education: A minimum of bachelor degree in construction/civil engineering, urban planning and other related disciplines. A master degree in related field is preferred.
- **b)** Work Experience: A minimum of overall 7 years of work experience post-completion of a Bachelor's degree, and a minimum of 5 years of specific work experience in construction, engineering, infrastructure and municipality projects is required, preferably in construction permitting. A minimum of 2 years of experience working in Government/ donor agencies/ large NGOs is required. Actual training and capacity building related experience, especially related to engineering in development programs, will be a distinct advantage.

Other Requirements:

- The incumbetant should have demonstrated knowledge in undertaking gap analysis, data collection, data analysis and planning. Knowledge of World Bank 'Doing Business' project and indicators is preferable.
- Practical knowledge of construction drawings (architecture, structure, MEP) and technical specification;
- Familiarity with municipality issues such as urban planning and designing, building codes, risk-based inspection, building safety and quality control mechanisms, sketching, construction permitting requirements, etc.
- Computer skills: Microsoft Office (Excel, Power Point, Word, Microsoft Project), SPSS
- Language skills: Strong written and verbal communication skills in English.
- Miscellaneous: Ability to work without supervision. Willingness to travel to the EZ-Kar urban coverage areas as required. Good training and communication skills. Willingness to work with a wide range of stakeholders.
